SITUATION

- Essential data relating to Star Automotive Hellas was stored on Mercedes Benz AG’s systems, to which it only had access for several months.
- This operational and historical data needed to be extracted, migrated, and integrated before the cut-off.
- Historical information was to be archived and accessible for the legal 10-year retention period.
- Mercedes Benz’s systems had strict security restrictions for data access and retrieval.
- Compatibility and integration with SAP and the Hellenization module were essential as was a user interface with the same look and feel as SAP.
- For future audits, information was to be provided to auditors in a standard format.

SOLUTION

- Tables and business objects for extraction were identified and all requirements were met regarding the Hellenization module.
- JiVS was configured to extract and import only the necessary data from Mercedes Benz AG’s SAP system and HANA database.
- Historical and operational data was stored on the JiVS on-premise platform, as the interim solution.
- Data was seamlessly integrated with Emil Frey’s SAP ECC system and the servers at its data center.
- Following user acceptance testing, the data was transferred from on-premise to the cloud version of JiVS.
